Count I

Did willfully, unlawfully, and feloniously operate a motor vehicle under the influence of intoxicating liquor or while having an alcohol concentration of eight one-hundredths (0.08%) or more in her blood as prohibited by and in violation of Section 63-11-30(1), Mississippi Code, 1972, as amended, and in a negligent manner caused the death of **Lisa A. Dedousis**, a human being, in violation of Section 63-11-30(5), Mississippi Code, 1972, as amended by in a negligent manner by crossing into the lane of oncoming traffic and/or operating a vehicle in excess of the posted speed limit.

Count II

Did willfully, unlawfully and feloniously operate a motor vehicle under the influence of intoxicating liquor or while having an alcohol concentration of eight one hundredths (0.08%) or more in her blood as prohibited by and in violation of Section 63-11-30(1), Mississippi Code, 1972, as amended, and in a negligent manner caused the death of **Daniel M. Pouge**, a human being, in violation of Section 63-11-30(5), Mississippi Code, 1972, as amended by in a negligent manner, crossing into the lane of oncoming traffic and/or operating a vehicle in excess of the posted speed limit.

Count III




